# terms & conditions

Please read these terms carefully. If you do not understand any of the terms or have any questions, please discuss the details with your Jimmy's on the Mall representative.

Clients are invited to read these provisions and note their responsibilities, arrangements for payments, cancellation terms, and limitations on the liability of Jimmy's on the Mall. The contract is conditional on the payment of the deposit.

**1. Booking Agreement:** A signed copy of this function contract along with the appropriate deposit is required to secure your booking.

**2. Confirmation & Tentative Bookings:** Any tentative bookings will be held for a period of 7 days only, after which time we may rebook the date. The booking is only confirmed once the deposit and booking form have been received.

**3. Deposits:** you will be required to pay a deposit disclosed by your function manager to secure your booking within 14 days together with the signed agreement to secure your booking.

**4. Price increases/menu variations:** All prices are current at the time of printing. Whilst we endeavour to maintain our price specified in our menus, we reserve the right to vary any quotes in the event of cost price increases in any foods and services supplied by Jimmy's on the Mall. All prices are subject to change up to 28 days before your event. Prices will be confirmed at the time of booking or not later than prior to your event, whichever is applicable.

**5. Surcharges:** A surcharge of 10% applies on Sunday's and 15% on Public Holidays.

**6. Final Payment:** All accounts are to be settled (3) days prior to the event. A final reconciliation of your account will be prepared following the event should there be additional charges.

Beverage charged on consumption basis may be settled by way of cash or credit card at the conclusion of the function. Any money owing to you will be refunded by EFT within fourteen (14) days after the event.

**Acceptable Payment Methods:** Credit card – Visa, MasterCard, Bankcard and Amex are also accepted. Direct Deposit details will be provided on request. 0.94% surcharge applies to all credit card payments.

**7. Final Numbers:** Jimmy's on the Mall requires anticipated final numbers, all catering arrangements, menu selection, room setup, times, theming, technical and entertainment details ten (10) working days prior to the event date. Final numbers are required five (5) working days prior to your event. Please note a surcharge of 50% of the total bill will be levied for any increase in numbers that occur after final numbers have been issued.

**8. Property Damage/Liability:** Organisers are responsible for any damage caused to any event area or surroundings by their guests, delegates, employees or agents before, during and after the event. Jimmy's on the Mall will not accept any responsibility for damage to or loss of any client's property / merchandise left prior to, during or after an event.

**9. Security:** If you require a security guard to exclusively serve your function, allowing only invited guests to attend, this must be organised at least one week prior to the event at additional costs. Please confirm with your Jimmy's on the Mall representative. We hold a Responsible Service of Alcohol Policy. We reserve the right to request identification for any such person and are not obliged to serve alcoholic beverages. Minors are only allowed to be in premises for the purpose of dining with their parents or guardian.

#### **10. Cancellation / Postponement Fee:**

Please understand a fee will apply and may involve the forfeit of your deposit. Please revert to the following deadlines:

- Notification of cancellation with 30 days or more notice will result in full refund of deposit if space is re-sold.
- Less than 30 days but more than 4 days – deposit will not be refunded
- Less than 4 days – client will incur full food and beverage spend charge

**Postponement:** Should your event be postponed with more than 45 days notice your deposit will be carried forward IN FULL to the new booking date. Should your event be postponed with less than 45 days notice your deposit is FORFEITED and a further deposit will be payable to secure the new booking date.
